

Executive Summary Capital Stock of Thailand in 2020

Overview

1. Gross Capital Stock

Gross capital stock at replacement cost in 2020 was 61,437.7 billion baht, reducing from 2019 by 716.6 billion baht. The negative outcome mainly resulted from a decrease in private capital stock by 1,174.0 billion baht, predominantly underpinned by the COVID-19 pandemic, which hindered the economic activities and weakened the overall economy. The private sectors directly impacted were tourism and export sectors influencing businesses to delay their new investment plans. Nonetheless, the gross capital stock of the public sector increased by 457.4 billion baht, according to an increase in the disbursement of public investment on both equipment and construction in the latter half of the year.

2. Net Capital Stock

Net capital stock at replacement cost valued at 38,419.7 billion baht dropped by 386.0 billion baht from 2019. However, compared to GDP at current prices, which was 15,698.3 billion baht in 2020, net capital stock at replacement cost was about 2.4 times larger than GDP.

2.1 Net Capital Stock classified by institutions

The private sector owned the majority proportion, accounting for 67.7% of total net capital stock and the remainder of only 32.3% held by the public sector.

2.2 Net Capital Stock classified by economic activities

- 1) Agricultural sector: net capital stock at replacement cost in 2020 recorded at 2,937.1 billion baht. By terms of chain volume measures, the net capital stock decreased by 1.4%, in contrast to an increase of 0.9% in 2019.
- 2) Non-agricultural sector: net capital stock at replacement cost in 2020 was 35,482.6 billion baht. In real terms, it dropped by 1.0%, in contrast to a rise of 1.3% in 2019. Precise details for the Industrial and service sectors are as follows.
- Industrial sector: net capital stock shrank by 0.3%, in contrast to a rise of 0.02% in 2019, due mainly to a fall in investment in manufacturing machinery.
- Service sector: net capital stock declined by 1.3%, sharply falling from a rise of 1.9% in 2019. The negative outcome was the reduction in major sectors, such as accommodation and food service activities, transportation and storage, wholesale

and retail trade and arts, entertainment and recreation. In addition, those sectors were severely affected by the spread of the COVID-19, which consequently caused investors to delay their investment plans.

3. Capital factor sector analysis and sources of economic growth in 2020

3.1 Incremental Capital Output Ratio: ICOR

Overview

In 2020, the Thai economy was adversely impacted by the COVID-19 pandemic, which caused a reduction in production and investment. Thus, net capital stock decreased. As a result, this year, ICOR registered at 0.41, which implied a one-unit drop in GDP, generating a decrease in 0.41 units in the capital factor. The following details presented the individual productivity as follows.

Agriculture sector: ICOR of the agriculture sector was 1.34. This year, there was a reduction in production and net capital stock due to a widespread drought leading to considerable yield losses.

Industrial sector: In 2020, the ICOR of the manufacturing sector was 0.10, resulting from a fall in both production and net capital stock of the industrial sector. An adverse outcome was from the outbreak of the COVID-19 pandemic domestic and abroad, in

combination with the lockdown measure obstructing the manufacturing production, as can be seen from the capital utilization rate falling from 66.28 in 2019 to 60.98 in 2020.

Service sector: ICOR was 0.49 due to a fall in its value added and net capital stock. The service sector was adversely affected by the measures to prevent and control the COVID-19 spread and travel restrictions which limited the number of tourists, so the number of foreign tourists decreased sharply this year.

3.2 Capital Productivity: CP

Overview

Capital productivity in 2020 was 0.38, falling from 0.40, which remained constant during 2017-2019. The decrease indicated that each unit of capital is used to produce 0.38 units of GDP. Capital productivity is discussed in detail below.

Agricultural sector: In 2020, capital productivity of the agricultural sector was 0.29, implying one unit of capital resulted in 0.29 units in agricultural value-added. However, compared to 0.38 of the national average, the agricultural sector had the least efficient capital productivity.

Industrial sector: Capital productivity of the industrial sector was 0.46. Based on this estimate, one unit of capital used in the industrial sector could contribute to 0.46 units of industrial value added. In 2020, CP was lower than the previous year, recording at 0.49, which remained at the same rate since 2017. Thus, capital productivity was continuing to fall from 0.50 in 2016; however, the capital productivity of this sector outperformed other sectors.

Service sector: Capital productivity of the service sector was 0.37, lower than 0.39 in the previous year. Compared to the 0.38 of the national average, the capital productivity of the service sector was slightly lower than the national average.




Figure 1 Capital Productivity of Thailand, 2015-2020

3.3 Total Factor Productivity: TFP

In 2020, the Thai economy plunged by 6.1%, in contrast to an increase of 2.3% in 2019. When considering the source of growth, the adverse effect was attributed to TFP and capital factor, which dropped by 5.53%, and 0.63%, respectively. However, the labour factor grew by 0.06%. The contraction of TFP was partly due to the COVID-19 pandemic, which prompted the control measures of the COVID-19 spread. Consequently, it caused inefficient capital usage. TFP by the source of growth is discussed below.

Agricultural sector: In 2020, the agricultural sector declined by 3.6%, compared to a fall of 0.6% in the previous year. When considering the source of growth, all factors recorded negative values, including a 1.1% fall of capital factor, a 0.01% fall of labour factor, and a 2.45% fall of TFP.

Industrial sector: The industrial sector in 2020 decreased by 5.9%, compared to 0.0% in 2019. In this year, all sources of growth recorded the contraction, consisting of a 0.72% fall of labour factor, a 0.18% fall of capital factor, and a 5.03% fall of TFP.

Service sector: In 2020, the service sector shrank by 6.5%, dramatically falling from a rise of 3.9% in 2019. This negative outcome contributed from the capital and TFP factors with decreases of 0.75% and 6.20%, respectively. However, the labour factor increased by 0.43% this year.


1. Overview


1.1 Gross Capital Stock

Gross capital stock at replacement cost in 2020 was 61,437.7 billion baht, decreased by 716.6 billion baht from 2019 because the private sector's investment fell by 1,174 billion baht; meanwhile, that of the public sector grew by 457.4 billion baht. In real terms or CVMs, gross capital stock decreased by 1.1%, in contrast to a 1.4% rise in the previous year, due mainly to the spread of COVID-19 disrupting the economic activities and causing uncertainty on the overall economy; consequently, directly affected private enterprises, particularly tourism sector, and exports. As a result, they needed to postpone their investment. However, the gross capital stock of the public sector increased by 457.4 billion baht, according to an acceleration of investment budget disbursement for equipment and construction in the latter half of the year.

1.2 Net Capital Stock

Net capital stock at replacement cost was 38,419.7 billion baht in 2020, decreased from the previous year by 386.0 billion baht. However, compared with GDP at current prices valued at 15,698.3 billion baht, the net capital stock was approximately 2.4 times higher than GDP's value.





2. Classification

The net capital stock is classified by the type of institutional sector and by the kind of economic activity.

2.1 Classification by institutional sector

The net capital stock is held by either public or private sector.

2.1.1 Public sector

Overview

In 2020, gross capital stock in the public sector recorded the value of 20,379.9 billion baht at replacement cost, increasing by 457.4 billion baht from 2019. With the adjustment of depreciation, the net capital stock was 12,421.3 billion baht.

In real terms, it increased by 2.2%, accelerating from a fall of 0.4% in the previous year. Notably, it resulted from rises in the assets of agriculture, construction, and real estate.

Structure of public sector net capital stock

Net capital stock at replacement cost acquired by the public sector was 32.3% of total net capital stock. It can be classified according to the type of asset as below.

- 1. Construction: In 2020, construction accounted for the largest share at 88.8% of total public sector net capital stock. The net capital stock of construction was mostly in infrastructural assets such as roads, bridges, dams, and irrigation systems.
- 2. Machinery and equipment: In 2020, machinery and equipment owned by the public sector accounted for only 11.2% of total net capital stock. The net capital stock of machinery and equipment was mainly in the other transport equipment owned by state enterprises and office equipment held by the general government.

2.1.2 Private sector

Overview

In 2020, the total value of gross capital stock held by the private sector at the current replacement cost was 41,057.8 billion baht, decreasing from 2019 by 1,174.0 billion baht. The net capital stock after deducting depreciation was 25,998.3 billion baht. In real terms, it dropped by 2.4%, in contrast to a 2.1% expansion in the prior year.

Structure of private sector net capital stock


Net capital stock at replacement cost held by the private sector accounted for 67.7% of total net capital stock. It can be classified according to the type of asset as below.


- 1. Construction: In 2020, the net capital stock of the private sector at replacement cost accounted for 53.2% of total net capital stock, where residential buildings covered 70.8% of total private construction, followed by office buildings and other construction respectively.
- 2. Machinery and equipment: At replacement cost, it accounted for 46.8% of a total portion which the majority of its assets were machinery and equipment for industrial activities and transport vehicles such as private cars, trucks, and buses.

2.2 Classification by the kind of economic activity

2.2.1 Capital stock by the kind of economic activity

Gross capital stock classified by the kind of economic activity comprises 19 different sectors as follows: agriculture, forestry and fishing; mining and quarrying; manufacturing; electricity, gas, steam and air conditioning supply; water supply, sewerage, waste management and remediation activities; construction; wholesale and retail trade, repair of motor vehicles and motorcycles; transport and storage; accommodation and food service activities; information and communication; financial and insurance activities; real estate activities; professional, scientific and technical activities; administrative and support service activities; public administration, defense and compulsory social security; education; human health and social works; arts, entertainment and recreation; and other service activities.

As aforementioned, gross capital stock at the current replacement cost in 2020 was 61,437.7 billion baht. Considering capital stock by the kind of economic activity, it reflected that transport and storage held the highest value of 11,503.5 billion baht, followed by real estate activities with the value of 10,914.1 billion baht, manufacturing with the value of 10,598.9 billion baht, electricity, gas, steam and air conditioning supply with the value of 4,908.6 billion baht, agriculture, forestry and fishing with the value of 4,908.3 billion baht, wholesale and retail trade; and repair of motor vehicles and motorcycles with the value of 4,591.2 billion baht, human health and social works with the value of 2,496.1 billion baht, construction with the value of 1,956.7 billion baht, accommodation and food services activities with the value of 1,870.9 billion baht, information and communication with the value of 1,405.9 billion baht, other services activities with the value of 1,377.5 billion baht, education with the value of 1,323.5 billion baht, public administration, defense and compulsory social security with the value of 1,126.1 billion baht, mining and quarrying with the value of 953.0 billion baht, financial and insurance activities with the value of 883.3 billion, water supply and sewerage, waste management and remediation activities with the value of 496.1 billion baht, administrative and support services with the value of 51.8 billion baht, arts, entertainment and recreation with the value of 37.3 billion baht, and professional, scientific and technical activities with the value of 35.1 billion baht.

Gross capital stock in real terms in 2020 decreased by 1.1%, falling from a 1.4% rise in 2019. Such adverse outcome this year was mainly influenced by a drastic contraction in accommodation and food service activities which plummeted by 15.9%; other sectors showing negative growth were as follows: wholesale and retail trade, and repair of motor vehicles and motorcycles (-3.8%), agriculture, forestry and fishing (-3.0%), transport and storage (-2.4%), and manufacturing (-0.4%). Nonetheless, some sectors continued to grow from last year, which were financial and insurance activities, which grew by 2.8%, followed by construction (2.3%), human health and social work activities (1.7%), information and communication, and electricity, gas, steam and air conditioning supply both expanded by 1.4%.

2.2.2 Net capital stock by the kind of economic activity

Regarding the net capital stock, the value at the current replacement cost in 2020 was 38,419.7 billion baht. The sector with the highest value was real estate activities with 7,351.8 billion baht, followed by transport and storage with 7,124.6 billion baht. Contrarily, professional, scientific and technical activities had the minimum value recorded at 20.3 billion baht.

In real terms (or CVMs), the net capital stock declined by 1.0%, down from a 1.3% rise in 2019. The contraction mainly reflected accommodation and food service activities, the significant decrease, recorded a 10.0% reduction; other sectors showing negative growth were wholesale and retail trade, and repair of motor vehicles and motorcycles (-5.1%), transport and storage (-3.8%), agriculture, forestry and fishing (-1.4%), and manufacturing (-0.7%). On the contrary, the sectors that continued growing from last year were public administration and defense; compulsory social security with a growth of 5.2%, followed by financial and insurance activities (4.1%), electricity, gas, steam and air conditioning supply (0.5%).




Figure 5 Structure of Net Capital Stock in 2020






Figure 6 Growth Rate of Net Capital Stock by the Kind of Activity and Institutional Sector




























3. Consumption of fixed capital or depreciation

Overview

Consumption of fixed capital or depreciation at current replacement cost was 3,016.7 billion baht, which accounted for 4.9% of gross capital stock at replacement cost. The sector with the highest depreciation was transport and storage with the value of 572.3 billion baht, representing 19.0% of overall depreciation, mainly due to investment in vehicles with an average life span of around 12 years, which is relatively short compared with building with the life span of around 50 years. The remaining sectors which held large portions of total depreciation were manufacturing recording a value at 545.3 billion baht; electricity, gas, steam and air conditioning supply at 330.6 billion baht; and real estate activities at 306.1 billion baht, which accounted for 18.1%, 11.0%, and 10.1% of total depreciation, consequently. The minimum contributors of overall depreciation this year were administrative and support service activities with a registered value of 4.4 billion baht, arts, entertainment and recreation with the value of 2.4 billion baht, and professional, scientific and technical activities with the value of 2.3 billion baht of which these three sectors held approximately 0.1% of total depreciation.



4. Capital Factor Analysis

4.1 Incremental Capital Output Ratio: ICOR

Overview

In 2020, the Thai economy was affected by the spread of the COVID-19, which lowered the production level in every sector while hampering investment, causing a decrease in net capital stock. As a result, the value of ICOR in 2020 was 0.41, implying that a 0.41 unit decrease in capital influenced a unit reduction of GDP. Nevertheless, the ICOR figure might not correctly reflect the efficiency of capital usage due to the impacts of the COVID-19 outbreak.

ICOR by the kind of economic activity

The following details presented ICOR by the kind of economic activity.

Agriculture: In 2020, ICOR was 1.34, which resulted from contraction in both production and net capital stock for the agriculture sector, partly exacerbated by widespread drought, making agricultural yield drop.

Industrial: For the industrial sector, ICOR in 2020 was 0.10, resulting from a reduction in production and investment in the industrial sector. Due to the spread of the COVID-19 in Thailand and worldwide, the mandatory lockdown in the domestic, industrial sector production plunged. As a result, the capital utilization rate fell from 66.28 in 2019 to 60.98 in 2020. When we considered ICOR averages from the eighth to the twelfth development plan, the twelfth plan has the highest ICOR value at 2.69, indicating the least efficient usage of capital during the period of consideration.

Service: ICOR of the service sector in 2020 was 0.49, it was a consequence of contraction in both production and investment for the service sector; moreover, the service sector got most severely hit by the measure for preventing the spread of the coronavirus along with travel restriction causing a drastic fall in the number of foreign tourists. When we considered ICOR averages from the eighth to the twelfth development plan, the twelfth plan has the ICOR value of 1.06, exhibiting the most efficient capital utilization.

4.2 Capital Productivity: CP

Overview

CP in 2020 was 0.38, representing that one unit of capital investment could generate 0.38 units of GDP, which was lower than that of 2019 with the value of 0.40. Over the last five development plans, CP continuously exhibited an upward trend. As mentioned, capital productivity increased from 0.31 in the eighth plan to 0.40 in the twelfth plan.

CP by the kind of economic activity

Agriculture: In 2020, the CP of the agricultural sector stayed at 0.29. Based on this estimate, one unit of capital served in the agricultural sector could contribute 0.29 units of value added to the agricultural sector. When comparing capital productivity to the national average with the value of 0.38 units, the agricultural sector had shown lower efficiency of capital usage than other sectors. From the eighth to the twelfth development plan, CP has continuously fallen from 0.48 units to 0.29 units.

Industrial: CP of the industrial sector in 2020 was 0.46, dropped from 0.49 in 2019. The estimation reflected that an increase of value added by 0.46 units in this sector would require a unit of industrial capital. Compared with the national average, the industrial sector outperformed other sectors in terms of capital usage efficiency. Adjusting capacity utilization to demonstrate the actual capital productivity reflected that CP attained would be 0.75, compared with 0.46 without correcting for capital utilization. Therefore, the industrial sector was still productive. When considering the averages of CP during the eighth and the twelfth national development plan, CP of the industrial sector has developed throughout the years from the value of 0.44 in the eighth plan to 0.50 and 0.51 in the ninth and tenth plan, accordingly, then marginally slowed down to 0.50 and 0.48 in the eleventh and twelfth plan, respectively.

Service: CP registered the value of 0.37 in 2020, which slightly fell from 0.39 in 2019, lower than the national average at 0.38. The average CP of the service sector has increased from 0.25 in the eighth development plan to 0.38 in the twelfth plan.




Figure 8 Capital Productivity

4.3 Total Factor Productivity: TFP

TFP is defined as the portion of GDP growth, which was not caused by a partial increase of any factor of production (labor, land, and capital). It would specifically refer to technological and administrative improvement, which accounted for an increase in output, typically measured as residuals.

Overview


In 2020, the Thai economy declined by 6.1%, falling from a 2.3% rise in 2019. The contraction reflected a 5.53% decline of TFP and a 0.63% fall of capital factor, although the labor factor grew by 0.06%. The negative value of TFP this year was partly due to the mandatory restriction for preventing the spread of the COVID-19 prompting inefficient utilization of capital assets.

When considering the average four years of the twelfth plan, the Thai economy had an average growth of 1.14, and the major source contributing to growth was a capital factor which accounted for 0.92%, while TFP stayed at 0.21%; although, labor and land factor have not had a significant contribution to growth. Compared with the previous plans, the ninth plan exhibited the highest rise in GDP and TFP, rising by 5.76% and 2.96%, respectively.


Agriculture

The agricultural sector diminished by 3.57% in 2020, compared to a reduction of 0.64% in 2019. When considering sources of growth, this contraction was attributable to a fall in all factors, which can be described as follows: TFP decreased by 2.45%, capital factor decreased by 1.11%, and labor factor decreased by 0.01%. On the other hand, for the twelfth development plan, the agricultural sector increased 1.62%, attributable to a 1.02% growth in capital factor, 0.57% by TFP, and 0.03% by labor factor. Moreover, considering the ninth to the twelfth economic and social development plan, the twelfth plan demonstrated the highest TFP contribution, though GDP showed the highest growth during the ninth development plan, which expanded by 2.96%, mainly driven by a rise in the capital.

Figure 10 Sources of GDP Growth in Agricultal sector




Industrial

In 2020, the industrial sector contracted by 5.94%, in contrast to the growth rate of 0.01% in 2019. In terms of source of growth, all factors provided negative impacts on the industrial sector which TFP was the main source with a drop of 5.03%, followed by labor factor with a decrease of 0.72%. When focusing on the current development plan, the four-year averages showed that the industrial sector decreased by 0.23%, affected by a 1.04% fall in TFP and a 0.40% reduction from labor factor, whereas the capital factor rose by 1.21%. Since the ninth development plan, TFP and growth of GDP continued to slow down from the value of 7.18% and 2.82% consecutively.

Figure 11 Sources of GDP Growth in Industrial sector




Service

The service sector fell by 6.52% in 2020, in contrast to a 3.89% rise in 2019. Considering the source of growth, the main factor attributable to this contraction was TFP which decreased by 6.20%, and capital factor decreased by 0.75%. On the contrary, the labor factor grew by 0.43%. When considering the twelfth plan, the average growth was 1.82%, contributed by 0.90% of TFP, 0.80% of capital factor, and 0.12% of labor factor. Regarding the evolution of TFP over the four consecutive development plans, the highest growth of the service sector occurred in the ninth plan, which expanded by 5.37%, and TFP had the highest growth rate at 2.83%.

ANNEX

Concept, definitions and methodology of Capital Stock of Thailand

1. Definition

- Capital is the assets used as factors of production of goods and services, usually consisting of fixed assets as well as financial assets. However, it refers here to only fixed assets, which are defined as tangible assets produced within an economy that can be used repeatedly for more than 1 year. They can also be replaced by the newly produced assets. Fixed assets consist of constructions and equipments.
- Gross Capital Stock (GCS) is sum of fixed assets accumulated over each asset's life as they are usually disposed after certain period of time when they can no longer provide the production service. GCS is generally measured at one point in time, specifically at the end of the year.
- Net Capital Stock (NCS) is the value of fixed assets after deducting depreciation
- Private Sector Capital Stock consists of capital stocks owned by private sector, covering both registered and non-registered ones as well as fixed assets acquired by households and non-profit institutions. For households sector, housing is the only assets considered as capital stock.
- Public Sector Capital Stock is all capital stock owned by public sector, which consists of central government, local municipalities, state-owned enterprises, all kinds of funds operated and controlled by the government, and independent agencies.
- Depreciation refers to depletion of fixed assets. As fixed assets are used repeatedly in production process, they become less productive, worn off and downgraded as new technology emerged. Thus, depreciation should be deducted from fixed assets each year, by how much depending on type of assets and their working life.
- Service lifetime is a period of time a fixed asset can be employed for production.

- Retirement of fixed assets from production process takes place when they can no longer provide production service.
- Incremental Capital Output Ratio: ICOR is an indicator measuring investment capacity in economic system. ICOR reflects how much additional investment is required for 1 unit increase in GDP. The smaller the ICOR, the higher efficiency the last unit of investment provides.

• Total Factor Productivity: TFP determines the proportion of GDP growth that is not a result of an increase in factors of production (labor, capital and land). This means TFP measures amount of GDP growth contributed by the residual or technical progress.

2. Coverage

Capital stock covers all fixed assets employed for producing goods and services in an economic system, categorized by institution, e.g. private sector, public sector, which includes central government, local municipalities and state-owned enterprises.

3. Methodology

Perpetual Inventory Method or PIM is applied here, which is an indirect method. This method is being used widely as this method draws basic data from accumulation of capital stock compiled under the System of National Accounts. As a result, outcomes from PIM are consistent with other national income statistics. The basic concept is to calculate the value of all fixed assets in one year, which covers capital stock at the first year as well as the additional capital acquired in following years subtracted by those disposed from production process. The total value of fixed assets at current price before deducting depreciation is Gross Capital Stock. In reality, however, all kind of assets wear out during production process such that the value of assets decline each year. Reduction in such value each year is called **Depreciation**. Thus, to find value of capital stock in existence or Net Capital Stock is simply by deducting accumulated depreciation from gross capital stock. An alternative approach for net capital stock is by adding last year net capital stock with investment during the year, then subtracting by depreciation.
